**Trevor Sofield** is Foundation Professor of Tourism, University of Tasmania. He has been undertaking tourism research in China since 1993, has made more than 20 research visits in the past decade, and has more than 30 publications on China to his name. He has been involved with the Chinese authorities in formulating ecotourism and cultural tourism policies in a number of Provinces in China including Anhui, Hubei, Hunan, Sichuan, Sha'anxi, Xinjiang, Yunnan and the Tibet Autonomous Region.
