Research for new knowledge is one among the three-fold functions of a university, the other two functions being teaching/training and community service. We must welcome Sabaragamuwa University academics for making the goal of its annual research forum of 2017 the search for "Knowledge

Igms". Thomas Kuhn, the historian of science who popularized the paradigm concept among scientists defined it as the doctrinal core that the majority of practising scientists are prepared to take for granted. From a broader sociological sense the term meant the entire constellation of beliefs, values, techniques and so on shared by the members of a given scientific community – a "world view" in a sense. Kuhn defined a paradigm shift leading to a change in the "world view" of the scientific community as a scientific revolution. A research forum organized with the objective of searching for knowledge beyond existing paradigms would indeed be aiming at truly lofty ideals.

As many countries in the world today, Sri Lanka too is increasingly becoming a 'knowledge economy' where the greater reliance is placed on intellectual capabilities of people rather than on the country's physical or natural resources.
