First of all, I extend my heartiest gratitude to Prof. M.S.M. Aslam for inviting me to participate in this conference. Second, I must thank the Vice Chancellor Prof. M. Sunil Shantha, Sabaragamuwa University in Sri Lanka, Prof. Athula

Gnanapala, Dean, Faculty of Management Studies, and the Conference Committee for their efforts in organizing this event. I would like to elaborate on the conference day on, How to innovate the tea industry with Teaics? In addition, I will talk about what is the role of universities to encourage the innovations in tea industry.

Universities must foster the human resources necessary for the industry, and the talents use the knowledge learned from university to secure practical skills and materialize the knowledge learned from higher education as practical intellectual property. The intellectual properties develop the industry and share the profits with the society. The purpose of Teaics was to make tea use for various purposes with an academic system, not just at the cultural level like other kinds of drinks. The tea has huge amount of information compared to other beverages, and the information had been obtained from the ones who shared tea culture and tea small holders. They made effort to obtain the tea culture contents overcoming difficult conditions from BC 2700. Since it is the role of the professors and scholars who researched tea to make more effective use of the value on tea, 189 subjects of teaics were developed through a sixstep process: experience-> recognition-> information-> knowledge-> theory-> science, study. Since the introduction of teaics, systemized tea studies have had one-word term and provided the opportunity to study tea at the knowledge system level. As a result, it is easier to collaborate with other studies and to classify knowledge in various ways. This provided a basis for using theories and sciences about teaics at a time and in a suitable place. Finally, I hope Sri Lanka Korea will become more powerful countries interdisciplinary research and cooperation.
