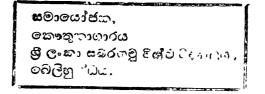

APPENDIX 1 - PROJECT DESCRIPTION



1. SUMMARY

This is the Quarterly Progress Report No.28 for the period October to December 1993, prepared by Joint Venture Samanalawewa (JVS).

Lot-II Contractor carried out Urgent Remedial Works instructed after the water burst on 22nd October, 1992.

All the urgent works have been completed in this period and Substantial Completion Certificate was issued on 03 November, 1993.

Lot VI Contractor had carried out the modification works of LLO Guard Valve and acceptably completed.

Lot VI Contractor had also carried out the emergency closure testing of the intake gate and successfully completed.

JVS and CECB Monitoring Team had continued the monitoring works during this perice.

PROJECT COST AND LOAN 2.

Table 2-1 shows the total project cost based on the estimated contract sums as of the end of Sept.'92.

The grand total project cost is estimated to be approximately Rs.18,304 million equivalent including contingencies (Foreign: Rs.12,192 million , Local: Rs.6,111 million) applying to exchange rate of \pounds 1.0 = Rs.56.0 and Rs.1.0 = $J_{4.0}$.

The Project is being financed by three sources of fund; the loans from the Overseas Economic Cooperation Fund of Japan (OECF), Government of the United Kingdom (UK Grant Aid, Commonwealth Development Corporation and Lloyds Merchant Bank Limited) and the annual fund of the Ceylon Electricity Board.

The summary of the loans is tabulated below.

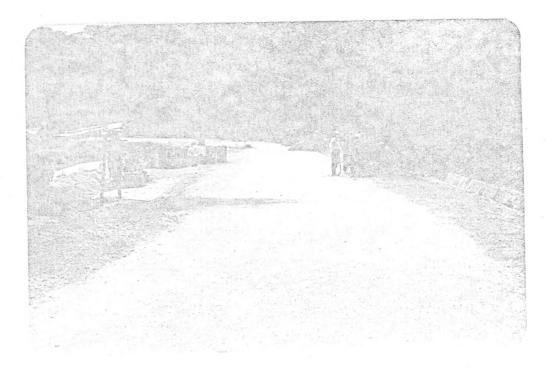

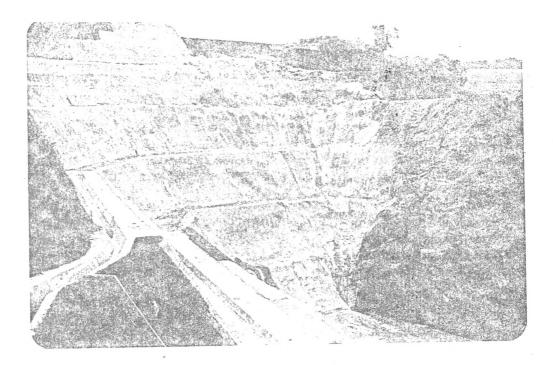


Pavement works for the permanent road upon the new slope

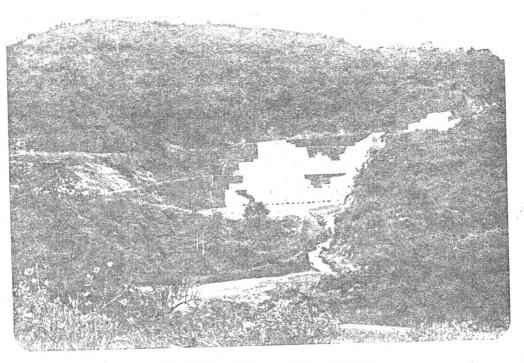


Pavement works - Completed





Slope stabilization - Completed



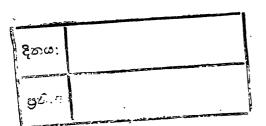
Slope stabilization - Completed (distance view)

DESCRIPTION OF THE PROJECT

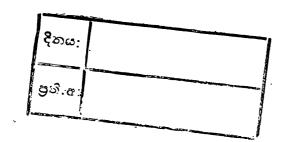
- (1) The project consists of the construction of a hydroelectric plant near Balangoda, approximately 100 miles south-east of Colombo (refer to Location Map attached herewith), with an installed capacity of 120 MW with provision for future extension of the powerhouse by an additional 120 MW to produce a firm 430 GWh of electricity per annum and comprises the following main elements:-
 - (a) a dam located on the Walawe Ganga River. The dam of the rockfill type with earth core and a crest level 105 m above the river bed level. The crest length is approximately 500m. The structures include an overflow chute spillway with three radial gates and a low level outlet/irrigation discharge outlet;
 - (b) a conduit system consisting of a 4,800 m long, 4.5 m diameter concrete lined horseshoe shape low pressure tunnel; a 18 m diameter 95 m deep surge chamber and a 950 m long 4.5 m diameter high pressure tunnel/penstock.
 - (c) a surface power station on the left bank of Katupath Oya River. The station will be equipped with two 60 MW Frances type turbine generator units discharging into a 580 m long tailrace canal. Energy will be transmitted from a 132 KV switch yard, adjacent to the power station, over 16 Km of double circuit overhead line to an existing substation close to Balangoda;
 - (d) a network of roads connecting the dam, intake, surge chamber and power station sites to the public road system. Electrical and water distribution, communication systems and fully serviced village will also be constructed. The access routes from Colombo to the site will be upgraded to take heavy construction traffic by bridge strengthening, road widening and the building or new river crossings.
- (2) Due to the additional Right Bank Cut-off Works to seal possible leakage path from the reservoir, commissioning of the turbine generators (2 units) will be postponed until July/August 1992.





(3) For implementing the project, the works are divided into eight (8) lots/contracts as follows:

1.	Lot-I,	:Civil Works - Diversion Tunnels and Relevant Works
2.	Lot-II	:Civil Works - Dam and Appurtenant Structures
3.	Lot-III	:Civil Works - Intake, Waterway,Powerhouse and Appurtenant Structures
4.	Lot-IV	:Power Generating Mechanical Plant - Turbines, Supervisory Control System and Relevant Works
5.	Lot-V	:Power Generating Electrical Plant - Generators, Ancillary and Relevant Works
6.	Lot-VI	:Hydromechancial Equipment - Gates, Valves, Penstocks and Relevant Works
7.	Lot-VII	:Local Contracts - Camps, Road Improvements, Power Supply, 33kV/132kV Transmission Line, etc.
8.	Lot-VIII	:132KV Transmission Line & Switching Station.
